7. New Business

- ♦ Motion 2022-07: "Motion to approve expense up to \$325 to purchase a gold sponsorship for the American Legion Golf Tournament April 9, 2022." Mover-M.Peele, Second-Greg Peele, Vote Passed-Unanimous
- ❖ Motion 2022-08: "I hereby move that we create an events special committee. The LPBC Chair will have the authority to appoint the committee chair." Motion pulled from agenda by Mari Peele
- ❖ Motion-2202-09: "I hereby move that we create an Outreach Special Committee. The LPBC Chair will have the authority to appoint the Committee Chair." Motion pulled from agenda by Mari Peele
- ❖ Motion 2022-10:"I move to authorize expenditure of up to \$150 for purchasing website related services including a domain name, hosting, email addresses, and associated costs." Mover-Mari Peele, Second-Greg Peele, Vote-4 Ayes, 1 Nay, Vote Passed 4 to 1.
- ❖ Motion 2022-11:"I move to amend previously adopted Motion 2022-03 to strike the line "Authorizes expending up to \$100 to purchase a physical credit card reader compatible with our Paypal or Stripe account;" and replace with "Authorizes expending up to \$200 to purchase and maintain a PNC Merchant Services account."

Discussion Information:



Paypal Zettle refused to approve our request for a card reader due to rejecting our identity documents even though Paypal itself accepted our identity. Investigating other options, we can either open a new account with Square (possibly with similar issues to Paypal) or sign up for a PNC Merchant Services account with our existing bank.

The cost for the PNC Merchant Services account is as follows:

- \$119 one-time cost for initial account setup and acquiring one Clover Go card reader
- \$4.95 / month security fee (for 11 months = \$54.45)
- Transaction fee of 2.60% + \$0.10 per swipe with card present
- Transaction fee of 3.45% + \$0.15 per keyed card entry

Additional card readers can be purchased after-market for \$50 if we need more than one or need to replace it. We can also upgrade in the future to the Clover Flex (small cell phone style receipt printer) or a full Clover Station (full tablet point of sale). The Clover account also enables us to key in transactions via the mobile app without the card reader similar to how we would do it in Paypal. It also supports setting up recurring monthly contributions like Paypal.

In the future, if we decide we like PNC Merchant Services, we can also purchase the website gateway for a one-time cost of \$99 to link our website to our Clover account. According to the representative, this supports all custom donor fields we need so this may remove the need to have a separate form before the actual payment like we do now with Paypal.

Advantages of PNC Merchant Services over Paypal



- Card payments deposit directly into party PNC checking account next day
- Lower per-transaction fees if card is present (2.60% vs 2.89%)
- Lower fixed fees on small transactions (\$0.10 / \$0.15 vs. \$0.49) major win for < \$60
- Established personal banking relationship at PNC Cocoa Commons SR 524 branch
- Automatically handed over with bank signatory updates
- New / replacement card readers can easily be purchased after-market online

Disadvantages

- Monthly \$4.95 fee regardless of whether any transactions are made
- Higher percentage fee if card not present (3.45% vs. 2.89%)
