Rationale: While Dontavious is not a Libertarian, he is not a registered member of any other party and therefore is still eligible to receive our support. He is a frequent attendee of Brevard County Commission and of LP Brevard events, and while I believe he is more of a pragmatic centrist than a radical, I believe he shares many of our priorities including transparency of the Brevard government, solutions for the IRL, and improving Brevard's fiscal responsibility and financial freedom. Certainly, I would prefer to see him elected over the Republican nominee (who per bylaws we would not be able to endorse anyways).

Addendum 5: Motion 2022-31

Title: Motion to Endorse NOTA for Brevard D4

Motion: I move for LPBC to endorse writing in "None of the Above" for Brevard

County Commission District 4 in the November 2022 general election.

Mover: Greg Peele

Rationale: The D4 election was closed by filing a placeholder write-in candidate Joseph Michael Aiello; otherwise it would have been an open primary. Obviously, this will result in Rob Feltner being elected since he won the Republican primary, and the write-in candidate was mostly just a patsy to help that happen (as somewhat infamously disclosed on Curt Smith's messages). So I cannot recommend endorsing Aiello. However, there will still be a write-in spot, and we can recommend people write in whatever they want in that spot. While "None of the Above" cannot be elected and likely won't be counted, it would still show up as undervotes indicating disapproval of Feltner.
