I move to amend the previously passed Motion 2022-25 by striking \$1500 and replacing it with \$2500.

Rationale: The Gala Committee has researched many avenues of advertising including mailers, radio, various public transport, digital advertising, and billboards. We had a meeting with a representative from Clear Channel who gave us pricing and metrics for digital billboards in Brevard County.

After comparing all of our options we decided that the best avenue to promote the event and therefore the party, would be a digital billboard on US 1 facing South 0.4 mi from SR 520. This billboard is at a stop light, 14' x 48', and would run for four weeks with an estimated 93,350 total impressions on drivers for the four weeks.
